## **Purpose of the Executive Director**

The NMCCV Executive Director reports to the State Service Commission, Commission Board of Directors, and DWS (NMCCV Fiscal Agent), the Executive Director (ED) has overall strategic and operational responsibility for the commission's staff, programs, expansion, and execution of its mission.

## **Activities/Items:**

- <u>Commission Support Grant</u>: worked with Program Officer on drafting and submitting
   Commission Support Grant application for FY 2017, including responding to CNCS clarifications.
- Budget: Met regularly with DWS finance staff to track the budget.
- <u>Compliance:</u> Met with DWS Legal staff on Commission administration. Attended Office of NM Attorney General training in Española with NMCCV staff on the Open Meetings Act and Inspection of Public Records Act.
- <u>Commissioner Recruitment</u>: Led the effort to recruit new NMCCV Commissioners to meet recruitment matrix by identifying and interviewing with Outreach Officer Kristin Hsueh seven (with five currently pending) potential appointees. Met with Commissioners Armijo-Brasher, Chavez, Dallago, Garza, Graff, Hallstrom, Humiston, Lee Chavez, Montoya; held monthly checkin calls with Chair Riordan.
- <u>Competitive RFP</u>: participated in Peer Review/Staff Review process.
- <u>Subgrantee Meetings</u>: participated in "check-in" meetings with Atrisco, NACA, Highlands and Teach for America. Participated in the December 16 Program Manager meeting in Santa Fe. Conceived summit on National Service and Education as an Economic Generator for 2017.
- Service Plan: Began designing tracking presentation with Commissioner Humiston and staff.
- <u>Training</u>: Participated in ongoing trainings offered by America's Service Commissions (ASC) designed for new Commission Executive Directors. Attended DWS trainings (new staff orientation, Living in a Union Environment and progressive staff evaluation).
- Outreach: facilitated meetings with Cultivating Coders, Social Impact and Nonprofit Community, Institute for Rural Social Work Research Consultation and Training and JumpStart to explore possible application opportunities during the 2017 "Formula" process, including a Healthy Futures Opioid reduction/prevention initiative for 2017. Facilitated meetings with consultants Vanessa Roanhorse and Ashley Sarracino on NMCCV outreach to Native American communities. Initiated (first of quarterly) NMCCV/CNCS NM staff meeting on December 9th in Santa Fe.
